

Terms of Service

1. Overview

Welcome to eternalchristmascard.com. By using this website and purchasing any products from us, you agree to comply with these Terms of Service. Please read them carefully before making a purchase.

2. Service Description

eternalchristmascard.com provides subscription-based Christmas card services where customers receive one Christmas card per year according to the plan they select (5 years, 10 years, or 40 years). Cards are shipped annually in November to the address provided at the time of purchase or to a new address if updated by the customer.

3. Subscription Plans and Payment

- **Pricing:** The current subscription packages are \$25 for 5 years, \$40 for 10 years, and \$100 for 40 years.
- **Payment:** Payment is required in full at the time of purchase and is non-refundable, except as specified in these Terms of Service.
- **Renewals:** Plans do not automatically renew. At the end of your subscription period, you may choose to renew or upgrade your plan.

4. Shipping and Delivery

- **Shipping Timeline:** We mail all Christmas cards in early December, with estimated delivery by mid December. While we aim for prompt delivery, card arrival before Christmas is not guaranteed.
- **Shipping Costs:** Shipping fees are included in the subscription price for standard delivery.
- **Address Updates:** Customers are responsible for providing an accurate address and updating it if they move. Address changes must be made by November 1 of each year to guarantee timely delivery.

5. Cancellations and Refunds

- **Cancellation:** Customers may cancel their subscription at any time, but no refunds will be provided for the remaining term of the subscription.
- **Refund Policy:** All sales are final. In the event we are unable to deliver cards as promised (e.g., due to supply chain issues), we reserve the right to either refund customers on a pro-rated basis or extend the subscription period as compensation.

6. Changes to Products and Pricing

- **Modifications:** We reserve the right to change the design of the cards, packaging, and other materials without notice. Any changes will not affect the quality or holiday spirit of the cards.
- **Price Adjustments:** Subscription prices are subject to change, but these changes will not affect existing, pre-paid subscriptions.
